**NOTE VERBALE**

The Embassy of the Hellenic Republic in Ankara presents its compliments to the Ministry of Foreign Affairs of the Republic of Turkey and, within the context of confronting effectively the pandemic of COVID-19, as well as protecting the population of the two countries and supporting tourism, has the honour, on behalf of the Greek Government, to propose the following understanding between the two Governments:

"The Government of the Hellenic Republic and the Government of the Republic of Turkey, taking into account that the Hellenic Republic and the Republic of Turkey (hereinafter referred to as "the two sides") issue digital certificates of the COVID- 19 vaccination containing the necessary technical security elements for electronic validation, including QR code, unique identifier and qualified electronic seal, and electronically validate the issued vaccination certificates through services available on the Internet, without the need for special authorization, which can be accessed using a link defined by a QR code or using a unique identifier, have reached the following understanding:

- The two sides should encourage mutual cooperation and the development of electronic services and the use of new technologies which significantly facilitate activities in the conditions of a global pandemic;

- The two sides should encourage the mutual use of the certificates of the COVID-19 vaccination issued by the two sides and methods of electronic validation of the certificates of the COVID 19 vaccination;

- A copy of the vaccination certificate of the Hellenic Republic is attached hereafter;

-The two sides support the establishment of mechanisms for co-operation in order to enable uninterrupted use of the vaccination certificates of one side in the procedures conducted by the competent institutions of the other side;

- The two sides support cooperation in the field of raising the importance of the use of the vaccination certificates, as an incentive for the development of tourism and facilitation of travel of citizens of both sides to the Hellenic Republic and to the Republic of Turkey respectively”.

If the above proposal meets the approval of the Government of the Republic of Turkey, the Embassy of the Hellenic Republic in Ankara proposes that this Verbal Note, together with the positive reply of the Ministry of Foreign Affairs of the Republic of Turkey, will constitute an agreement between the Government of the Hellenic Republic and the Government of the Republic of Turkey, effective as of the date of receipt of the reply of the Ministry of Foreign Affairs of the Republic of Turkey, and continuing until such time as the two sides acting together, or either side acting unilaterally, shall decide to terminate such agreement.

The Embassy of the Hellenic Republic in Ankara avails itself of this opportunity, to reiterate to the Ministry of Foreign Affairs of the Republic of Turkey, the assurances of its highest consideration.
